PREAMBLE :

Earlier Govt. in R&B Deptt, vide G.R.No.MCN-1671-(97)-H(Pt.IV)
dt.1.10.'80 has substituted appendix-XVI of P.W.D. Manual
Volume-II, regarding rules pertaining to renting of articles
of T&P to contractors etc. wherein, in the Annex-A clause
13(B), under light transport vehicles, the life of Jeeps and
Ambassador Cars was fixed 1.60 lacs Kms/10 years/14%.

Now due to modern technology, proper maintenance and better
road conditions it was under consideration of Govt. to modify
the life already indicated above. It has however been
observed that vehicles are rendering service beyond 1.6 lacs
Kms. performance of these vehicles is satisfactory beyond
1.6 lacs Kms. with periodical maintenance and repairs, more
life in terms of Kms, is possible.

: RESOLUTION :

After careful consideration, now the issue of enhancement of
life of light vehicles like Ambassador cars and jeeps in
Kms. it has been decided to modify the life of Ambassador
Car & Jeeps as under :-

Sr.No.	Equipment.	Life in Kms. as per GR dt.1.10.'80.	Life in Kms. now fixed.
1.	Light transport Ambassador Car & Jeep.	1.60 lacs kms.	2 lacs kms.
